## 3. Introduction

Kerala State Film Development Corporation (the “Authority”) is the implementing agency/Special Purpose Vehicle for implementation of projects undertaken by Department of Cultural Affairs with the funding from Govt or other agencies.

KSFDC invites Expression of Interest for empanelment of qualified Architectural/ Engineering firms for different categories based on project cost and for empanelment based on technical qualification and experience. KSFDC will empanel architects for each category based on evaluation criteria mentioned in the EoI document.

## 4. Objective

The broad objective of the empanelment is to avail the services of qualified, experienced and competent Architectural/Engineering, Structural Design Consultancy, Theatre Consultancy firms, MEP Consultancy firms, AV & Acoustic Consultants for the projects being taken up by KSFDC. The aim is to have a list of Empanelled Architectural/ Engineering firms for consultancy for different categories of works. KSFDC will scrutinize the design and plans of various development activities. This EoI document is for short listing suitable qualified Architectural/ Engineering firms and empanel them for **5 Years** to avail the services of architecture, interior designing, structural design, MEP designing, estimates, landscape, theatre and AV & Acoustic designs for the projects being taken up by KSFDC.

## 6. General Scope of Works

The scope of work for Architectural/Engineering consultancy firms included architectural design, structural design, MEP designs, Theatre and AV & Acoustic designs, landscape designs, Interior detailing, detailed estimates and preparation of Detailed Project Report as prescribed by the funding agency for different projects. Architectural/ Engineering Firm shall be the lead consultant and all other firms shall be in-house or hired through partnership/joint ventures. Once finalised the consultants listed in the EOI shall not be changed.

On completion of Empanelment for the above categories, based on the requirement of comprehensive services for each category, a project brief shall be issued to the empanelled firms. Then limited tender shall be floated amongst the empanelled group of firms for the requirement of comprehensive services against each category. Through the online limited tender, empanelled firms shall participate for the technical presentation and financial proposal. The selected applicant shall be awarded the contracts for the consultancy services.

The empanelled firms will have to make a presentation explaining the details of their profile, and also the understanding of the concept, the work plan & methodology to be employed and concept ideas of proposed projects in the presentation. The presentation will have to be made before the selection committee who will evaluate the presentation along with the financial proposal and award based on the evaluation criteria. A minimum of **15 days' time** will be allowed for making the presentation.

## 7. Terms of Reference

### 7.1 The Scope of Work

- I. The empanelled Architectural/ Engineering firms and associated consultants should understand the significance of the project, its unique challenges and opportunities and ensure the benchmark design and performance standards.
- II. To prepare concept design, architectural design, preparation of detailed drawings with macro, micro level detailing, 3D views and Detailed Project Report.
- III. To prepare structural design, calculations, reports drawings, MEP design, calculations, reports Theatre designs and AV & Acoustical, Interior drawings and estimates etc required for completion of the particular project adhering to the applicable norms and standards.
- IV. To prepare GFC drawings for execution for all project components

V. Providing one full time Civil Engineer and MEP engineer at site for coordinating the works till completion who shall be guided by senior engineers of the empanelled firm.(rate shall be quoted separately)

VI. Site visits by the senior team members of the respective stream Monthly / as and when requested by KSFDC.

VII. The firm is required to provide architectural/ Engineering services in respect of following:
